

## Guideline to Overseas Academic Presentation Scholarship Option II for Graduate Student's and Postdoctoral Fellow's Publication

### A: Applicant's Qualification

- 1) Must be CU Graduate student or CU Postdoctoral fellow.
- 2) Must hold papers published with first author, advisor as corresponding author with CU affiliation.
- 3) Have papers published/accepted/submitted with minor revision in ISI/SCOPUS database before graduation for student and the end of contract for postdoctoral fellow. His/her journals must not be published in Scholarly Open Access, Beall's List of Predatory Open-Access Publishers as stated in <http://scholarlyoa.com/publishers>
- 4) Submitted manuscript with major revision can be used to apply but must follow (3) within 20 days after the end of the conference/symposium.

### Academic papers requirement for applicant as following:

### B: Scholarship Conditions

- 1) Chulalongkorn University will support all expense within financial support rate for international Oral/Poster presentation.
- 2) Academic presentation topic must never be presented in international conference/symposium. It may be the topic related to the paper in the above table or other papers of applicant as first author/co-researcher.
- 3) Conference/Symposium attendance must be within 6 months after graduation/the end of contract.

### C: Financial Support Rate

#### **D: Consideration Criteria**

An applicant must submit a complete application form, including the following documents for support consideration, to Graduate School via his/her program and faculty at least 30-days before departure date to the conference/symposium.

- 1) Full paper as stated in academic paper requirement table and a letter of publication acceptance for accepted paper
- 2) Evidence showing that above journal is categorized in ISI or SCOPUS databases.  
Printed evidence of quartile (Q) ranking of journals from SJR/ISI website must be provided as well.
- 3) An acceptance letter/email showing to be a part of the Oral/Poster Presentation may be included or submitted before payment claim. The payment will be canceled if these documents are not shown.
- 4) Details involving the conference/symposium (daily program, registration rate etc.)
  - (i) Abstract presented at the overseas academic presentation and
  - (ii) Manuscript or full paper submitted or accepted or published in the journal.
- 5) Expenses approximation within the amount of financial support.

#### **E: Support cancellation**

- 1) Recipient is no longer a student/postdoctoral researcher at Chulalongkorn University before the departure date to the conference/symposium). Except for the recipient who graduated/ended of contract within first- six months before conference/symposium.
- 2) An acceptance letter/email to be part of the Oral/Poster Presentation is not submitted before payment claim.

#### **F: Payment Claim**

The recipient must submit the following documents within 20 days after the end of the conference/symposium presentation.

- 1) Registration Receipt with the document showing exchange rate issued by the Bank of Thailand
- 2) Airplane Ticket Receipt of Economy Class or E-ticket and Boarding pass
- 3) Accommodation Receipt issued by the hotel
- 4) Payment Certificate for Daily Allowance
- 5) Transportation Report for Academic Presentation
- 6) Academic Presentation Report at International Conference /Symposium

#### **G: Conditions for Scholarship Recipient**

1) Recipient must contribute knowledge gained from International Conference/Symposium within one month by giving a lecture/seminar or other activities that are benefit for graduate studies. Recipient must report this contribution to Graduate School within one month.

2) If recipient's full paper is published in the journal, recipient should report to Graduate School as well.
